

[i] NOTE: States that currently have SPA have until by October 13, 2018 to reapply in order to retain their SPA status. Owners and operators in these states must continue to follow their state requirements until the state changes its requirements or until the state's SPA status changes. Owners and operators in 16 non-SPA states and territories must meet the federal requirements according to the schedule in the 2015 UST regulation. In addition, owners and operators will need to follow their state requirements. A year in parentheses indicates the state has received SPA approval from EPA for its revisions that incorporate the 2015 federal amendments.

[ii] NOTE: Many states have previously adopted part of the 2015 UST amendments that were included in the UST provisions of the Energy Policy Act of 2005. In addition, EPA added new operation and maintenance requirements and addressed UST systems deferred in the 1988 UST regulation.
